## EMBREY MILL'S 2019 FACEBOOK BERRY & WINE FESTIVAL PROMOTION WINNERS MUST COMPLETE AFFIDAVIT

## **OFFICIAL RULES**

NO ADDITONAL FEE, PURCHASE OR PAYMENT IS NECESSARY TO PARTICIPATE. OPEN ONLY LEGAL U.S. RESIDENTS AGED 18 YEARS OR OLDER. VOID WHERE PROHIBITED BY LAW. THIS PROMOTION IS GOVERNED BY THE LAWS OF THE COMMONWEALTH OF VIRGINIA AND THE UNITED STATES.

- 1. PROMOTION: Embrey Mill's 2019 Facebook Berry &Wine Festival Promotion (the "Promotion") begins at 9:00 a.m. EST on Thursday, April 11, 2019 and ends at 12:00 p.m. EST on Friday, May 3, 2019 (the "Promotion Period"). Participation in this Promotion is subject to these Embrey Mill 2019 Facebook Berry & Festival Promotion Official Rules ("Official Rules"). NASH Stafford, LLC ("Sponsor") is conducting the Promotion to market and increase interest in the Embrey Mill Community ("Embrey Mill") and its homebuilders ("Builders"). To participate in the Promotion and enter for a chance to win the Prize (as defined below), eligible individuals (each a "Participant") must: (i) "Like" the Contest Alert posted by Sponsor on its Promotion Facebook page, (ii) "Tag" three (3) friends Participant wishes to attend the Berry & Wine Festival with on May 11, 2019; and "Share" Sponsor's Contest Alert posting. There is no payment or purchase necessary to enter, participate and/or win. The information collected in connection with this Promotion will be used by Sponsor in its marketing efforts for Embrey Mill. Participants will be eligible for the random drawing ("Drawing") as set forth below where the Prizes will be awarded. Participants need not be present to win.
- 2. **ELIGIBILITY:** The Promotion is open only to legal residents of the United States who are 18 years of age or older as of the commencement of the Promotion Period. Employees, contractors, or agents of Sponsor, Newland Real Estate Group, LLC ("**Newland**"), or of any Builder or any of their parent companies, affiliates, agents, or subsidiaries, as well as the immediate family (spouse, parents, siblings, and children) and household members of such employees, contractors or agents, are not eligible to participate. Details and qualifications for participation in this Promotion apply and are set forth in these Official Rules.
- 3. **SPONSOR:** The Promotion is sponsored by NASH Stafford, LLC whose business address is: 25 Apricot Street, Stafford, VA 22554 ("**The Embrey House**"). Newland, as property manager, has been retained to administer the Promotion on Sponsor's behalf.
- 4. AGREEMENT TO OFFICIAL RULES: Participation in the Promotion constitutes Participant's full and unconditional agreement to and acceptance of these Official Rules, as may be amended in the sole discretion of Sponsor, and the decisions of Sponsor, which are final and binding in all respects.
- 5. **REGISTRATION:** Individuals may register for the Promotion by following Embrey Mill's Contest Alert posted on the Promotion's Facebook page, tagging three (3) friends Participant wishes to attend the Berry & Wine Festival with on May 11, 2019, and "Sharing" Sponsor's Contest Alert posting. Any effort by a Participant to misrepresent himself or herself through

the use of aliases or otherwise, will disqualify the Participant from the Promotion. Sponsor is not responsible for any incorrect or inaccurate information supplied by any Participant during participation or otherwise in connection with the Promotion.

- 6. **DRAWING AND PRIZES:** On Friday, May 3, 2019 at approximately 12:00 p.m. EST, Sponsor will conduct a random drawing ("Drawing") from among all eligible entries received to select Eight (8) winners (each a "Winner") of two (2) free tickets to Embrey Mill's 2019 Berry & Wine Festival being held on May 11, 2019 (the "Prize"). The verifiable retail value of each Prize is approximately Thirty and No/100 U.S. Dollars (\$30.00). Winner's right to receive a Prize is not transferable or assignable. No substitution, cash redemption or transfer of right to receive Prize is permitted, except in the sole discretion of Sponsor, which reserves the right to substitute Prize with an item of equal or greater value. The Prize consists only of the item expressly specified in these Official Rules. Drawing will be conducted by Sponsor at The Embrey House. Odds of winning depend on the number of eligible entries received. For example, if 100 entries are received and Participant has submitted a single entry, the odds of winning are 1:100. Potential Winner may be notified by telephone and/or e-mail, at Sponsor's discretion. Winner is subject to verification. Winner will be required to complete and return to Sponsor an Affidavit of Eligibility/Release of Liability/Publicity Release, and IRS W-9 Form within ten (10) days of attempted delivery of same. - 13. **DISPUTES:** By entering, each Participant irrevocably agrees that any and all disputes, claims, and causes of action arising out of, or connected with, the Promotion shall be resolved individually, without resort to any form of class action, and exclusively by arbitration under the current rules of the American Arbitration Association. Arbitration will take place in Stafford County, Commonwealth of Virginia, which shall be the appropriate venue for any such disputes, claims or causes of action. Each Participant hereby waives any claim that he or she is not subject personally to the jurisdiction of said courts or that any such suit or other proceeding is brought in an inconvenient forum or improper venue. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the Participant and Sponsor in connection with the Promotion, shall be governed by, and construed in accordance with, the laws of the Commonwealth of Virginia, without giving effect to any choice of law or conflict of law rules or provisions (whether of the Commonwealth of Virginia, or any other jurisdiction) that would cause the application of the laws of any jurisdiction other than the Commonwealth of Virginia.
